Engineer's Report

CDBG has called for projects for 2014. The council would like KJ to apply for water improvements for the next funding cycle. At this point, Fairfield will still qualify for funding since the new survey that HUD will use has not been implemented.

Rate analysis

KJ has prepared a rate analysis for the sewer fund. The fund has been hit extremely hard with the matching funds for the sewer improvement projects along with the major repairs that have been done. The rates the Town is charging are keeping the fund on track at this point.

OLD BUSINESS

Latah Electric

Jeannie has been diligent in working with Latah Electric to get their performance bond, which arrived today. The price of the bond is \$870. Derek has also added the optional outside light installation to the original bid price. The cost on that is \$384.84 including tax. Not only is this energy-efficient, long life LED light fixture reasonably priced for commercial application, it is virtually maintenance free with an average rated life of 100,000 hours (20 years, no bulb changes).

ACTION

Mary motioned, seconded by Harry to approve the addition of the performance bond for \$870 and \$384.84 for the optional outside light installation to the original generator bid. The motion carried.

309 W Lake Street

Terry Ottosen presented a bid to abate the residence at 309 W Lake Street. The council discussed the need for bond on a job this size and decided to utilize the council's right to waive the bond requirement. Terry is used by the Town as the code enforcer. The Town will place a lien on the property for reimbursement.

ACTION

Mary motioned to approve the expenditure of \$1250 for abatement of 309 W Lake and to place a lien on the property for reimbursement, seconded by Brian. The motion carried.
