## Cemetery mowing contract

Cheryl Fulton-Fischer contacted the office to state that the cemetery board would like to keep the cemetery mowing contract with John Thomas. The council was in agreement.

## 2020 Census-Participant Statistical area program

This document demonstrates the census block and census tract changes in Spokane County since the 2010 census. There were no significant changes in our area. Cheryl will notify SRTC that the council agrees. No other action is needed.

### 402 W Portland Water leak

The homeowner of 402 W Portland had their pipes freeze and break under their home and has petitioned the town for an adjustment on their next bill. Emily Thomas reviewed the details of her actions and determined that the owner did everything according to our Code I 3.04.200. Therefore, her recommendation is to waive the overage charges related to this leak and charge the account holder only the base charge for this billing cycle with overage calculations to resume beginning with the next reading of this meter. Cheryl did an estimated calculation of about \$180 dollars overage.

Emily moved to waive the overage charges related to this leak and charge the account holder only the base charge for this billing cycle-with overage calculations to resume beginning with the next reading of this meter; seconded by Jamie. The motion carried 5-0.

## An Example of a Regular Task:

Bacteria Samples (15 Min.)

Once a month a bacteria sample is taken from a tap in our water system. This sample is taken to be sure there are no harmful chemicals in our water system, helping in ensuring drinking water safety. This sample is reported to DOH and kept on record at Fairfield Town Hall and in the public works department, you can see the results hanging on the wall in the town office.

### **ACTION**

Because of the emergency of the SCADA system failure, Valerie moved to approve the purchase a new SCADA system, up to 25k; seconded by Jamie. The motion carries 5-0.

Complaints that came in were passed on to the Planning/Improvement Board (PCIB).

#### Other

Deputy Bruner from the Sheriff's office introduced himself as the sheriff that will be covering our area for now.

David Watling let the council know that their neighbor's dog was on their property and bit his wife but did not break the skin. SCRAPS was called but they did not send a car for investigation. Deputy Bruner informed us that SCRAPS' guidelines are very specific and if there was no skin broken with the bite, it was more than likely not ruled an emergency or dangerous situation.
