# Request from local daycare to use the Community Center as an emergency location

Ashley Lightfoot requested that the community center be allowed on her emergency plan for her local daycare. Emily Thomas made a motion for the community center to be used as an emergency location. Jamie Paden seconded. The motion carried 4 yes-0.

## **Public Works Report**

Sewer: Wastewater Samples will be taken in this week. The WWTF is no longer discharging.

**Streets**: 1st St. Sidewalk project is completed.

Cascade will be out again soon to complete Main St. sidewalk repairs.

Parks: Park benches are completed and back in the parks.

Water: Road grade water meter lids have been picked up. This month meter lids in need of repair will be replaced.

THM and HAA5 samples will be taken in this month. Both tests are routine compliance tests with the state testing for disinfection byproducts in our water.

**General:** Dump truck tires have been replaced due to being in bad condition and one being punctured and flattened.

One front backhoe tire was replaced due to being in poor shape and weathering.

### An Example of a Regular Task:

Cleaning UV room, and discharge area (5 Hrs.)

Fairfield Public Works cleans the UV disinfection lighting system regularly. This is the final form of disinfection for our wastewater before being delivered back into the creek. This is an important area to keep clean to ensure adequate disinfection important to the environmental safety, this also serves a major part in insuring that the town meets our wastewater permit levels of disinfection and in final water quality. In both the summer when we stop discharging and again in the fall when we start discharging, we do a major cleaning of the entire room and all equipment to insure a safe and sanitary environment for taking samples and working in. This also ensures we are meeting expectations for the water to be returned into the creek.

#### Other

Valerie Rogers questioned if the Pit could be used by the football league. No one disputed the use.
