PUBLIC HEARING FOR Ordinance #395 Final 2021 Budget

Bank situation

Cheryl was notified by a few residents that their payment made on May 29th had been deposited for a second time, causing some to have an overdraft. After discussing this with a First Interstate employee, she explained that they had been testing a new software program, which was to stay in-house but it had gone live causing activity to post on the accounts being tested. There was no actual double deposit made and that the people who had been affected were notified and any charges they incurred were corrected. The test was to stay in-house but it had gone live causing it to appear as the town had made a duplicate deposit. The bank took care of everyone's charges and will be issuing a letter appear to be filed in the December 2020 bank information. None of those transactions should appear on any of

our bank statements.
