Mayor Pro-Tem Valerie Rogers called the October 18, 2022 regular council meeting to order at 6:00 at the Community Center.

The meeting opened with the Pledge of Allegiance.

Town Clerk Cheryl Loeffler swore in Valerie Rogers to the appointed mayor position.

Mayor Valerie Rogers appointed the current members of the Fairfield Improvement Board Justin Gust, Tim Murphy, Mark Starr and new members Anthony Schurr and Josh Stanley.

Bonus for all employees

At the October 4th meeting, using the ARPA funds, the public works employees were given a one-time \$1,000 premium pay bonus for being essential employees during the COVID-19 pandemic. Discussion tonight to provide the clerk/treasurer the same thing.

NEW BUSINESS

Band fundraiser

SRTC Meeting

The surrounding town clerks and two mayors met with Lois Bollenbeck from SRTC and discussed a variety of transportation challenges that impact small, rural towns and potential opportunities for SRTC to provide support. Topics included roadway classification (for federal aid & unpaved roads), safety, grants and funding, and general needs. The SRTC Director informed members of a potential Regional Transportation Safety study and the upcoming need to re-appoint a representative to SRTC (discussion included the appointment of an alternate as well.
