# REGULAR COUNCIL MEETING SEPTEMBER 3, 2024 6:00 P.M. COMMUNITY CENTER

### **Excusal of Council Absences**

### Correspondence and/or Guest

### **Public Comments**

Pastor Debbie announced that Cynthia Davidson's memorial service would be Saturday 09/07/24 at 2:00pm at the Fairfield Community Church. Pastor Debbie also announced that there would be a food drive to help the North Palouse Food Bank with pick up happening via a "hayride" around town on Sunday, September 29<sup>th</sup>.

### **Old Business**

## Updates to Employee Handbook

The handbook was updated and discussed at the previous council meeting but needed a council vote to ratify it.

#### **ACTION**

Alisha Anderson made a motion to approve the 2024 updates to the employee handbook; this was seconded by Bill Enzler. The Motion passed 4 to 0.

### **New Business**

#### .gov domain

The Town of Fairfield received approval for a .gov domain website. This will provide additional legitimacy to the town website and provide additional security measures. Jared will work with Kayla Billington of KBITs in getting the website updated and switched over.

**Sewer:** Sewer samples went in this week.

WWTF Lift Station #2 fault.

Water: Working on Lead Service Line Inventory per the EPA. Due October 16th.

Cameras and security systems are being installed around our department buildings, wells, and reservoirs.

### An Example of a Regular Task:

### High levels of Air in the Water System

Concerns have been brought up about high levels of air in the water system. This may lead to "milky" colored water when pulled from the tap. Other potential issues may be sputtering or noises as water comes from your faucets. There may also be small amounts of sediment that are stirred up due to the air in the system. This may be present when you use the water faucets.

This is a seasonal issue the town is aware of and has been working to address for a few years now. In this time not only has our Public Works Crew and in house Water Operator been working to resolve this, but Fairfield has also reached out to many different operators, Public works

crews, engineers, Evergreen Rural Water of Washington (ERWOW), Idaho Rural Water Association (IRWA), and Washington State Department of Health Office of Drinking Water (DOH ODW). Unfortunately, this has proven to be not a simple problem to solve. Initially when this issue came up it was isolated to one well but has progressed to all three of Fairfield's primary wells. This has caused the air in the water to be unavoidable without finding the cause. For example, we are unable to isolate a particular well for summer use. Fairfield has performed ongoing troubleshooting and investigation into this issue. We have been checking water drawdown, static, and dynamic levels of all primary wells insuring aduqite water supply. Checking amperage draw of the wells. Reducing GPM and flow rates of each well, to assist with any overdraw or cavitation issues has been attempted. Fairfield has increased well rotation of operation, which seems to allow more of a break for each well between runtimes allowing for higher quality water. We have also recently installed air relief valves at some fire hydrants throughout town to mitigate the issue, although this is only a temporary assistance to the overall issue. In a continued attempt to remedy this issue Fairfield has been in the process of applying for grant funding, this would allow us to further investigate and address the root of the issue appropriately.

We assure you that Fairfield is taking this matter seriously and has been and will continue working to resolve this issue. If there are any further questions or concerns about this matter, please reach out to Town Hall or our Public Works Department.
