Excusal of Council Absences

ACTION

Amanda Blood moved to excuse Mayor Rafferty from tonight's meeting; this was second by Alisha Anderson. The motion passed 4 – 0.

Alisha Anderson made a motion to excuse Josh Boyd from the regular council meeting on June 17th 2025. Bill Enzler seconded; and the motion passed 4 – 0.

Correspondence and/or Guest
