Correspondence and/or Guest

Bryan Hicks presented different funding options that are currently available and will pursue funds to rehab the Main Street bridge, as suggested by Spokane County. Bryan will also look into funding through the Dept. of Ecology to update Fairfield's sewer plan. Historically this has been only 50% covered with the Town providing the other half through a low interest loan. Estimated project cost is around \$200K.

Jim Rinehart attended council explaining the situation around the complaint that was made about the horse on his property. The mayor will discuss further with the PCIB for a suggested course of action.

Ken Fuchs presented information on the benefits of road oiling. A discussion was had regarding the town's responsibility of costs for this service.
